ZTE Corporation and its majority owned or controlled subsidiaries and affiliates (collectively, "ZTE") are fully committed to compliance with all applicable export control and economic sanctions laws and regulations. ZTE has committed and will continue to commit substantial resources to ensure compliance with applicable export control and economic sanctions laws and regulations around the world. Throughout this past year, ZTE has continued to expand its Export Compliance Program, including initiating new projects to implement enhanced compliance measures and providing additional internal and external training programs.

中兴通讯股份有限公司及其控股或控制子公司和附属机构（统称“中兴通讯”）完全致力于遵守所有可适用的出口管制和经济制裁法律法规。中兴通讯已经并将继续投入大量资源，确保在全球范围内遵守可适用的出口管制和经济制裁法律法规。在过去的一年里，中兴通讯持续深化其出口合规项目，包括设立旨在执行提升举措的新项目以及额外的内外部培训项目。

The Export Compliance Committee— which is the chief organization for ZTE's export compliance management—and all ZTE management fully support ZTE's ongoing goal to have a world-class Export Compliance Program based on industry best practices. This past year, ZTE made significant advancements in export compliance and will continue to build on that progress to further enhance its Export Compliance Program. It is the responsibility of every individual to fully support this effort.

ZTE's Export Compliance Program will continue to be subject to audits, monitoring and assessments (including regular announced and unannounced site visits), by the Special Compliance Coordinator ("SCC"), appointed by the U.S. Department of Commerce, Bureau of Industry and Security<sup>1</sup>. Any failure to fully comply with ZTE's Export Control Compliance Policy and Management Commitment Statements regarding cooperation and honesty with the Export Control Compliance Department ("ECC") or the SCC will result in significant discipline up to and including termination.

中兴通讯的出口合规项目将继续接受由美国商务部工业安全局任命的特别合规协调员(“SCC”)的审计、监督和评估(包括定期进行事先告知或不予事先告知的现场访问)<sup>2</sup>。任何未能遵守中兴通讯的《出口管制合规政策》和《管理层承诺声明》中有关于与出口管制合规部(“ECC”)、SCC 诚信合作要求的行为,将导致严重的纪律处分,最高可至(包括)解除劳动关系。

Please review ZTE's 2022 Export Control Compliance Policy, and understand and follow the requirements of the Policy. All directors, officers, employees and contract employees must comply with all applicable export control and economic sanctions laws and regulations as well as all policies and procedures promulgated by ZTE to ensure compliance. Under no circumstances will exports, re-exports or transfers (in-country) be made contrary to laws and regulations or policies by any individual or entity on behalf of ZTE. For example, ZTE's import and export activities are subject to the Export Control Law of the People's Republic of China when certain products are subject to China dual-use controls. In addition, ZTE makes certain products incorporating U.S. content that are fully controlled by the U.S. export control and economic sanctions laws and regulations, including products subject to national security/dual-use controls. Accordingly, all directors, officers, employees and contract employees must fully understand how export control and economic sanctions laws and regulations apply to the work that they do, participate fully and in good faith in all applicable compliance training, report any actual or potential compliance issues or violations to the appropriate compliance personnel, ensure that business documents, records, data and information are accurate and complete and that required records are maintained and filed in the proper locations, and ask questions of BU

Compliance Team, ECC or the Chief Export Compliance Officer (“CECO”) if they are uncertain as to what requirements might apply.

请审阅《2022年中兴通讯出口管制合规政策》，理解并遵循该政策的要求。所有董事、管理人员、员工和合同工都必须遵守所有可适用的出口管制和经济制裁法律法规以及中兴通讯为确保合规而颁布的政策和流程。在任何情况下，任何个人或实体均不得代表中兴通讯在违反法律法规或政策的情况下开展出口、再出口或转移（国内）活动。例如，当特定产品受中国军民两用管制时，中兴通讯的进出口活动会受到《中华人民共和国出口管制法》管辖。又如，中兴通讯制造的特定产品会并入受美国出口管制和经济制裁法律法规管控的美国成分，包含因美国国家安全/军民两用管制规定而受控的产品。因此，所有董事、管理人员、员工和合同工必须充分理解出口管制和经济制裁法律法规如何适用于其工作，充分地、诚信地参与所有适用的合规培训，向适当的合规人员报告任何实际或潜在的合规问题或违规行为，确保业务文档、记录、数据和信息准确完整，并对上述信息做好记录保存，以及在合适的位置归档，同时在不不确定哪些要求可能适用时，向BU合规团队、出口管制合规部或首席出口管制合规官（“CECO”）提出咨询。

Violations of the export control and economic sanctions laws and regulations may result in serious consequences for ZTE and responsible individuals, including criminal and/or civil fines, sanctioned party designation and even imprisonment, or re-imposition of the Suspended Denial Order as well as damage to ZTE's and the individual's reputation. Anyone found to be in violation of the laws and regulations or policies will be subject to disciplinary actions by the Company, up to and including termination, in addition to legal responsibilities.
